

## CHIROPRACTIC IN SWITZERLAND

Since September 1<sup>st</sup>, 2007 the Federal Law on Education of the Medical Professions (Medizinalberufegesetz [MedBG](#) – Loi sur les professions médicales universitaires [LPMéd](#)) is in effect. It regulates the education, postgraduate, continuing education and professional activity of the five medical professions, the physicians, the dentists, the chiropractors, the pharmacists and the veterinarians.

The federal legislation effects the education, the diploma and the postgraduate education of chiropractors.

### EDUCATION

Chiropractic students have the possibility to study either in Switzerland or abroad.

#### Switzerland

The first course in chiropractic started at the University of Zurich in fall 2008.

### **FEDERAL EXAM - FEDERAL DIPLOMA**

The federal exam in chiropractic medicine allows for practice as a chiropractor under supervision in Switzerland. Admission requirements are a diploma from an accredited course of study in chiropractic. In addition, candidates must have acquired 60 ECTS from a course of study in a Swiss university leading to a degree in a medical profession, i.e. medicine, chiropractic medicine, dentistry, pharmacology or veterinary medicine. For chiropractors with a foreign diploma, we recommend that these 60 ECTS are acquired in year three of the master in chiropractic medicine program at the University of Zurich. The federal exam is offered in French and German.

### **YEAR 3 OF MASTER IN CHIROPRACTIC MEDICINE (PRACTICAL YEAR):**

Admission in the status of guest student upon passing the clinic entrance exam (usually in mid-May). Rotations as an underassistant in the Policlinic for Chiropractic Medicine (6 months) and in the different clinics of the University Hospital Balgrist in Zurich (5 months). In addition, a case report, suitable for publication must be written during these eleven months. Students that successfully complete year 3 of the master program are awarded 60 ECTS. A master's degree of the University of Zurich is not awarded. Deadline for the registration for the clinic entrance is end of January in the year of the exam. A German language diploma (Goethe Institute level C1) must be handed in together with the registration.

### **FAILURE TO PASS THE CLINIC ENTRANCE EXAM**

The clinic entrance exam allows 1 resit (1-2 months later or in the following year). In the year between the 1<sup>st</sup> exam and the resit, students may apply to sit in classes of the 2<sup>nd</sup> year as guest students provided that there are places available. No ECTS are awarded for attending these lessons.

Students that failed the clinic entrance exam twice do not have any further possibility to acquire the 60 ECTS in the chiropractic medicine program at the University of Zurich. If the option above of taking year 3 of the master in chiropractic medicine is for any reason not feasible, candidates may acquire the 60 ECTS by the successful completion of a first year of medicine, dentistry, veterinary medicine or pharmacology. These courses are taught in French at the Universities of Fribourg, Geneva, Lausanne and Neuchâtel.

## **POSTGRADUATE EDUCATION - FEDERAL POSTGRADUATE TITLE**

Prerequisite to be admitted to the postgraduate education (assistantship, postgraduate courses) is the federal diploma. The postgraduate education as well as the postgraduate exam is offered by ChiroSuisse/ Swiss Association of Chiropractors and leads to the federal postgraduate title. The postgraduate exam is offered in French and German.

## **PROFESSIONAL ACTIVITY**

The federal postgraduate title is the prerequisite in order to practice chiropractic in his/her own office in Switzerland independently.

In addition to this a chiropractor needs a cantonal work permit and when working for the social insurances: a concordat number ([Zahlstellenregisternummer/Registre des codes-créancier](#)) of SASIS. Chiropractors with a federal postgraduate title who prefer to work dependently (employed) have to apply for a control number (K-Nummer/No C).
